Terms & Conditions

I. Eligibility Conditions

The bidder should own at least one Light Commercial Vehicle (not older than 2008 Model). If the bidder does not own a LCV at the time of bidding he/she has to submit an undertaking in writing that vehicle shall be acquired within 15 days of the finalization of the tender.

2. Documents required to be submitted along with the bid

The bidder shall furnish the following documents along with the bid:

- (i) Document showing ownership of one Light Commercial Vehicle (not older than 2008 Model) or the undertaking as per 1 above
- (ii) Earnest Money of required amount in form of Demand Draft or Cash Receipt.
- (iii) Valid Service Tax Registration Certificate. If bidder is not liable to pay the service tax as per law, he/she should submit a self- certificate to that effect.
- (iv) Latest Income Tax return along with copy of PAN card.

Failure to furnish all the required information as per Bid Documents, the bid is liable to be considered as substantially not responsive and may result in rejection.

All the pages of the tender document and certificates should be duly signed by the bidder.

3. Packing of Bid Documents

The Technical Bid along with supporting documents and the Price Bid should be put in two separate sealed covers superscribed as "Technical Bid" and "Price Bid" Both these sealed covers should be put in to another sealed cover superscribed prominently as "**TENDER FOR PROVIDING OF LIGHT COMMERCIAL VEHICLES**" Tenders received without proper sealing are liable to be rejected.

4. Price Bid

- (i) The bidder is required to quote the rates with the Make and the Model of vehicle in the prescribed proforma. Rate should be quoted in figures & words without any overwriting, corrections, errors, omissions etc. Any corrections in bid or rate sheet are required to be signed by the bidder otherwise tender may be rejected summarily.
- (ii) The rates quoted by the bidder shall remain fixed during the entire period of the contract and shall not be subject to variation on account of any changes in input cost. A bid submitted with an adjustable price quotation will be treated as non-responsive and will be rejected.
- (iii) Discounts etc. if any mentioned by the bidders shall not be considered.

6. Earnest Money Deposit

- (i) The bidder must deposit Rs 7000/- (Rupees Seven Thousands only) as EMD (Non-Interest Bearing). The EMD shall be in the form of Cash Deposit Receipt / crossed DD from any nationalized bank payable at Ambala in favour of C.A.O. O/o CCA Haryana Telecom Circle, Ambala.

Signature of Bidder

- (ii) The successful bidder's EMD will be discharged/adjusted upon the bidder's acceptance of the award of contract satisfactorily in accordance with Clause 10 of Section I and furnishing the performance security.
- (iii) The bid security may be forfeited in the following conditions:-
 - (a) If the bidder withdraws his bid during the period of validity.
 - (b) If the successful bidder fails to sign contract within a week of the issue of letter of intent.
 - (c) If the successful bidder fails to furnish performance security in accordance with Clause 10 of Section I.
 - (iv) The bid security of the unsuccessful bidder will be returned as early as possible, after signing of the contract with successful bidder.

7. Submission of Bid

- (i) The bids should be duly sealed and addressed to CAO (ADMN) O/O CCA, Haryana, and dropped in the Tender Box provided in the O/O CCA Haryana Telecom Circle, CTO Compound, Lawrence Road, Ambala cantt-133001, upto 15:00 hours of the due date.

8. Tender Opening

- (a) The bids shall be opened in the presence of the bidders or their authorized representatives who wish to be present at the time of opening of bids on due date and time, at their own cost. The Technical Bid shall be opened, first and the **Price bids shall be opened only of those bidders who qualify technically.**

9. Bid Evaluation

9.1 Bids shall be evaluated to determine whether they are complete, whether any computational errors have been made, whether documents have been properly signed (**all the pages should be signed**) and whether bids are generally in order.

9.2 If there is any discrepancy between words and figures, the amount in words shall prevail. Prior to detailed evaluation, CCA, Haryana will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which conforms to all the terms and conditions of the bid document, without material deviation. A bid determined as substantially non-responsive will be rejected by CCA, Haryana.

9.3 CCA, Haryana shall evaluate in detail and compare the substantially responsive bids as indicated in the Price Bid in Section V and Evaluation of the bid as per Section VI.

10. Performance Security

10.1 The successful bidder shall be required to furnish performance security of Rs.25,000/- (Rs. Twenty Five Thousands only) at the time of signing the contract.

Signature of Bidder

10.2 Performance Security shall be submitted in the form of Bank Guarantee issued by a scheduled bank in the Performa provided in Annexure VI of the bid document or cash or crossed demand draft.

10.3 If the contractor fails or neglects any of his obligations under the contract it shall be lawful for CCA, Haryana to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting in such failure.

11. Award of Contract

CCA, Haryana shall consider placement of letter of intent to the bidder whose offer has been found technically, commercially and financially acceptable. The bidder shall within 7 days of the issue of the letter of intent give his acceptance and sign agreement with CCA, Haryana.

12. Right to vary Quantities

CCA, Haryana reserves the right to increase or decrease the required quantity of service without any change in the hiring charges of the offered quantity and other terms and conditions.

13. Signing of Contract

Signing of Agreement shall constitute the award of hiring contract on the bidder.

14. Annulment of Award

Failure of the successful bidder to comply with any of the tender/contract conditions shall constitute sufficient ground for the annulment of award and forfeiture of the bid security in which event CCA, Haryana may make the award to any other bidder at his discretion or may call for new bids.

15. Right to Accept or Reject

CCA, Haryana shall not be bound to accept the lowest or any other tender and reserves the right to accept or reject any offer.

16. Termination of Contract

16.1 CCA, Haryana may, without prejudice to any other right/remedy for breach of contract, terminate the contract in whole or in parts by giving 3 (three) clear days notice in writing to the contractor in case of any default by the contractor/service provider and in any of the terms and conditions.

a) If the contractor fails to arrange the supply of any or all of the vehicle(s) within the period specified in the contract or any extension thereof granted by the CCA, Haryana.

b) If the contractor fails to perform any other obligations under the contract agreement, CCA, Haryana may, without prejudice to any other rights under the law or the contract provided, get the hiring done at the risk and the cost of the contractor, in the above circumstances.

16.2 Notwithstanding anything contained herein, CCA, Haryana also reserves the right to terminate the contract at any time or stage during the period of contract, by giving three days notice in writing without assigning any reason and without incurring any financial liability to the service provider/contractor.

Signature of Bidder

17. Termination for Insolvency

CCA, Haryana may also by giving written notice and without compensation to the service provider/contractor terminate the contract if the service provider becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

19. Miscellaneous Conditions:

19.1 CCA, Haryana reserves the right to counter offer against price quoted by the bidder.

19.2 CCA, Haryana reserves the right to disqualify such bidders for a suitable period who fail to honour their bid without sufficient ground.

20. Force Majeure

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of CCA, Haryana as to whether the supplies/services have been so resumed or not shall be final and conducive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

21. Arbitration

21.1 In the event of any question, dispute or difference arising under the agreement in connection therewith (except as to matters, the decision to which is specifically provided under this agreement) the same shall be referred to sole arbitrator appointed by the Secretary, DoT. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitration and Conciliation Act, 1996, or any statutory modification or re-enactment thereof or any rules made thereof.

21.2 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid Arbitration and Conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.

21.3 The venue of the arbitration proceeding shall be the office of CCA, Haryana at Ambala or such other place as the arbitrator may decide.

22. Set-Off (Recovery of Sum Due)

Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by CCA, Haryana and set-off the same against any claim of CCA for payment of a sum of money arising out of this contract or under any other contract made by contractor with CCA, Haryana.

23. Terms of Payment

Payment shall be made within 30 days from the date of receipt of bill and found correct and valid in all respects in the O/o CCA, Haryana. Monthly bills shall be submitted in duplicate to the CAO (ADMN) O/o CCA, Haryana, Ambala.

24. Duration of the Contract

Normally the contract will be awarded for One year. However, extension for the One Year thereof will be considered keeping in view various factors such as prevailing market rates, satisfactory performance of the firm.

SECTION II
SPECIAL CONDITIONS OF THE CONTRACT

1. The special conditions of contract shall supplement the General (commercial) conditions of the contract as contained in Section I and wherever there is a conflict, the provisions herein shall prevail over those in Section I.
2. Office of CCA, Haryana, reserves the right to blacklist a bidder for a suitable period in case he fails to honor his bid without sufficient ground.
3. Any liability under any Act or Statute shall be of the contractor and under no circumstances shall CCA, Haryana assume responsibility.
4. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labor laws and regulations is the sole responsibility of the contractor. Any breach of such laws or regulations shall be deemed to be breach of this contract.
5. No sub-contracting is permissible.
6. The near relatives of all employees working in office of CCA, Haryana, either directly recruited or on deputation are prohibited from participation in this tender. The near relatives for this purpose are defined as:
 - (a) Members of a Hindu Undivided Family.
 - (b) They are husband and wife.
 - (c) The one is related to the other in the manner as father, mother son(s),son's wife(daughter- in - law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) husband (brother-in-law).
7. The contractor shall assign the job of driving vehicles to experienced drivers having appropriate license and also assume full responsibility for the safety and security of officers/officials as well as essential store items while running the vehicle by ensuring safe driving. CCA, Haryana shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under Section 29 of IPC and any loss caused to CCA, Haryana have to be suitably compensated by contractor.
8. The contractor shall send the vehicle for periodical servicing at the cost of the contractor, CCA, Haryana will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes, insurance etc. is the contractor's liability.
- 9 Regular checking of meter by the designated transport authority may be done by the contractor and requisite certificate may be shown to CCA, Haryana as and when demanded.
10. Shortage in utilizing the contractual 2000 Kms per month in any particular month will be adjusted over a period of subsequent three months.
11. The toll tax and parking charges only shall be reimbursed on submission of proper receipt/s. This does not include any entry fee or other charges prescribed by any authority.
12. Change of commercial vehicle of same type and model will be allowed on written request and approval of controlling officer showing the reference of previous vehicle & Kms run of that vehicle during that quarter. Old and new vehicle will be considered in continuation for counting shortage in utilizing the contractual 2000 Kms in particular month of that quarter.

Signature of Bidder

13. The vehicle may be used any where in the territorial jurisdiction of Haryana, including Chandigarh and Delhi.
14. Change of other type of vehicle will be allowed during break down of that vehicle and with written approval of controlling officer.
15. TDS applicable will be deducted from the payable amount of the bill.
16. Driver should not be suffering from any serious/contagious disease. He must be healthy.
17. The contractor shall abide by all local/municipal/sate/central laws and regulations.
18. The drivers should be provided working mobile phone at the cost of the contractor, so as to enable the CCA Haryana office to contact them as and when required, during the period of the contract.
19. Payment of all kinds of Government taxes or duties for plying vehicles in Haryana, will be the liability of the contractor.
20. In case the date fixed for the opening of the bids is declared as holiday by the Government of India, the revised schedule will be notified. However, in the absence of such notification, bids will be opened on the next working day, time and venue remaining unaltered.
21. Tampering of meter reading, vehicle usage timings overwriting of summary/log book sheets and misbehavior by the drivers while on duty shall be viewed seriously and may lead to even termination of the contract at the discretion of the CCA, Haryana.
22. The Service provider/contractor shall not engage any person below the age of 18 years.
23. Contractor shall not display, "On Govt. Duty" signboard/plate during the period vehicle is not in use in the office.
24. The driver should be in proper dress as prescribed by the competent authority/Transport authority.
25. During night halt the contractor/driver will have to make his own arrangement for stay. This office shall not be responsible for anything whatsoever.
26. CCA, Haryana reserve the right to interpret any of the terms & conditions of this document.

SECTION IV

SERVICES TO BE PROVIDED

1. Service: Provision of commercial vehicles with licensed drivers, registered commercial vehicle on hiring basis for running in Haryana, including Chandigarh and Delhi.
2. Contract Period: Under normal circumstances the contract shall be valid for a period of one year from date of signing of agreement. However, contract may be extended for further period up to One Year if agreed to by the contractor and the CCA, Haryana on the same rate and other terms and conditions.
3. Quantity: Estimated number of vehicles to be hired is One However it should be clearly noted that Office of CCA, Haryana may place the order for additional vehicle as per the actual requirement from time to time.
4. Duty hours: Though generally there is five days week in the office but vehicle can be requisitioned on non working days also for field inspections or office work.
5. Notice: 1) Telephonic intimation shall also be considered as notice.
- 6 (a) Reporting Place: Any place within the jurisdiction of the Office of CCA, Haryana. Actual place of reporting shall be specified by users of vehicle.

(b) Jurisdiction: Vehicle shall be required to run to any station within the territorial jurisdiction of Haryana, Chandigarh and Delhi.
7. Counting of Distance: When vehicle is in use for actual journey by officers of CCA, Haryana
8. Accuracy of Meter reading: The accuracy of meter reading should tally with the actual distance of run at any instant and controlling / authorized officer shall have full power to check up the meter for its correctness and to take action to recover the actual loss to the Office of CCA, Haryana.
9. Penalties: I) **In case of break down, vehicles have to be replaced by another one immediately or within one hour. In case of non availability of suitable vehicle a penalty up to Rs. 500/- may be imposed in addition to deduction on pro-rata basis for**

the period. If the number of break down exceeds three times in a month, a penalty of Rs. 600/- per break down shall be imposed.

II) In case of non-availability of vehicles penalty of Rs.1000/- per day shall be imposed in addition to deduction at pro-rata basis for that day.

III) In case of non- availability of vehicles during extra hours Penalty of Rs.400-/ per occasion shall be imposed.

IV) In case of meter found faulty, one month's charges shall be deducted as penalty. The vehicle with faulty meter should be repaired immediately or vehicle should be replaced till the meter is rectified. The controlling / authorized officer shall have full powers to check up the meter and to take action to recover the actual loss to the CCA, Haryana.

10. Special

- I) Intending bidder must have a telephone where requisition of Vehicles can be conveyed all the 24 hrs. Telephone Number must be specified in the bid.
- II) Payment of any Govt. tax including service tax or duty for plying the vehicles in the service area will be liability of contractor.
- III) Parking and Toll charges, if any, may be claimed by producing the Parking / Toll slips.
- IV) The improper conduct of the contractor/driver shall be sufficient reason for termination of the contract and to engage another vehicle from the market at the risk and cost of the contractor.
